**Bylaws Amendment** 

No copies available for member review.

President Benoit reading change as submitted by Ken Haag in bold type.

Bylaws ARTICLE II – MEMBERSHIP

Section 2. Right of Members to Vote.

Each membership shall be entitled to one (1) vote on any question requiring a vote of the membership of the Society, except for participants in household memberships. Each household membership shall be entitled to a maximum of (2) votes. Each membership shall be entitled to vote on any question requiring a vote of the membership of the Society. The Board shall specify the number of votes that a membership unit may cast as determined by the membership category The right to vote of a group membership shall be exercised by an individual designated in writing as the official delegate for the group. A group is any affiliated organization, agency or business other than a Chapter of the Society.

President Benoit Do we want to sever the two portions and separate the right of membership to vote from the 25% rebate? What it says here is that they are not really related so we can take these as two separate portions. One would be changing "that each household membership shall be entitled to a maximum two votes". Then the wording would be changed to "the board shall specifiy the number of votes that may be cast as determined by the membership category". We have changed the membership category. We do have Patron and Life. According to the Bylaws, currently the household membership has two votes and the Patron, Sustaining, and Life are hanging out there in limbo. I guess, with one. We will sever these two sections: The right of the membership to vote' and will be separate from the 25%. Does anybody have questions about changing the words "the board shall specify the number of votes that the membership unit may have as determined by the membership category". Does anybody have comments about that?

At current time, the Bylaws state "Each household membership shall be entitled to a maximum of two votes. Otherwise, each membership shall be entitled to one vote......
